

NO LIMITS COMPANY TEAM CONTRACT 2008-2009

THIS CONTRACT IS TO ENSURE UNDERSTANDING OF COMPANY REQUIREMENTS BETWEEN PARENTS, DANCERS AND NO LIMITS DANCE STUDIO, INC.

1. By being selected for the No Limits Dance Company for 2008-2009 you are committed to the company rehearsals, tuition, competition costumes, convention outfits and convention & competition fees from July 20, 2008 through July 31, 2009. In the event a student decides to resign from the No Limits Dance Company prior to the end of the season he or she will not be allowed to audition for the Company again.

2. All members of the No Limits Dance Company must attend and participate in all conventions and competitions.

a. If a company member misses a competition or convention the student will not be eligible to compete in the next competition (unless there are extenuating circumstances).

3. As a member of the No Limits Dance Company, you may not receive dance instruction from another local dance studio.

a. This does not include master classes or workshop classes.

4. During the summer, students of the No Limits Dance Company must attend a full week of classes. Students may split the days between both studios. Dance is a year round activity that requires training in the summer months in order to maintain technique and encourage growth.

5. Company rehearsals the week before and the week of competitions are MANDATORY and dancers must participate (unless there are extenuating circumstances).

6. All Company members will need to purchase a complete warm up (jacket and pants) a company t-shirt as well as hair supplies, tights, shoes and all accessories for competitions.

7. Parents of the Company must join the No Limits Dance Parents Booster Club. The fee is \$25 per year (previously start up fee).

8. Company members will have a mandatory dress code for rehearsals. All dancers must wear their hair in a low pony tail with a right side part, a leotard, tights with no holes and all dance shoes. A demerit will be issued each time the student is not prepared. After three demerits are issued the student will lose their solo or be pulled from a dance for the following performance/competition.

9. When possible, understudies will be used to fill in a position when needed (i.e. demerit system).

10. The No Limits Dance Company attends three to four conventions/competitions each year as well as a National Competition.

11. Attendance is CRUCIAL and EXPECTED. Excessive absence not only hurts the team member but other members of the team. Extenuating circumstances that contribute to an absence may be discussed with Mandy. Private lessons at a cost of \$40 an hour will be required for any member missing two of the regularly scheduled monthly rehearsals.

12. Choice of music, dancers and costumes for routines is solely up to the instructors. Not every dancer will be in every dance. Dancers will be placed

accordingly to their ability and where they can succeed.
